**Abigail DeVille** is an artist who creates large sculptures and installations. DeVille's work has been exhibited at The Whitney, The Studio Museum in Harlem, The Bronx Museum, and many more. Abigail has been featured on Art21's *Extended Play* and *New York Close Up* series.



**Nicole Deller** is a former lawyer and advocate for issues of international security, human rights, and the protection of women and children. She has experience with all aspects of non-profit operations, including strategic guidance, content development, and management.
